Product identification	The product is an aluminium composite panel manufactured by AKPA, identified by its panel thickness, aluminium skin thickness, core material type, surface coating specification, dimensions, and color, as defined in the relevant technical standards and order documentation.
Product description	Aluminum Composite Panel is a composite building material formed by bonding a low-density polyethylene core between two pre-treated, painted aluminum sheets using advanced manufacturing technology. Although the composite panel is aluminum-based and lightweight, it combines metallic strength with superior flatness, vibration absorption, high durability, and ease of maintenance. Aluminum composite panels are predominantly used as cladding materials for interior and exterior façades of buildings, and may also be utilized in the advertising and decoration sectors. Depending on the properties of the core material, aluminum composite panels may be available in different fire performance classifications.
Technical purpose of product	The technical purpose of the aluminium composite panel is to provide a lightweight, high-stiffness, and weather-resistant façade and cladding material for exterior and interior building applications. The product enables design flexibility, ease of installation, and long-term performance while contributing to modern architectural aesthetics.
Manufacturing description	Plastic granules are used as the main raw material and are melted using electrically heated mixers and extruders at temperatures up to approximately 180 °C. The molten plastic core is combined with externally supplied aluminum sheets and adhesive layers through a rolling process to form the composite structure. The panel passes through an electrically heated oven to ensure proper bonding and surface quality, followed by multi-stage rolling and controlled cooling to approximately 40 °C. Protective film is applied upon customer request, and the panels are cut to the required dimensions before shipment. Production scrap is mechanically separated into aluminum and plastic fractions; aluminum is sent to licensed recycling facilities, while the plastic fraction is reprocessed and reused in production.

LCA INFORMATION

Description of data quality assessment and reference years: The Life Cycle Assessment (LCA) for this Environmental Product Declaration (EPD) is based on both primary and secondary data. Primary data were collected directly from the manufacturer's production processes and site-specific operations for the reference year 2024. The quality and representativeness of all data used for the EPD have been evaluated in terms of time, geography, and technology according to the principles outlined in EN 15804:2012+A2:2019, Annex E, and the data quality requirements specified in EN 15941:2010 for life cycle data. All relevant datasets were reviewed for completeness, consistency, and reliability, and the assessment confirmed that no data were classified as "poor" or "very poor" in quality.

A1 - Raw Material

This stage includes the extraction and processing of raw materials required for aluminium composite panel production. It covers primary and secondary aluminium production for the aluminium skins, raw material production for the core material (e.g. polyethylene core), surface coating materials, upstream energy use, and associated emissions related to raw material supply.

A2 - Raw Material Transport

The A2 stage includes the transportation of materials from suppliers to the profile manufacturing plant. It accounts for fuel consumption, transport distances, load factors and vehicle types used. All emissions and energy use related to transport operations are included in this stage.

A3 - Manufacturing

This stage represents the manufacturing of aluminium composite panels, including surface coating of aluminium sheets, continuous lamination of aluminium skins to the core material under controlled temperature and pressure, curing, cutting to size, quality control, and packaging. It includes on-site energy and water consumption, auxiliary materials, internal transport, process waste, and emissions generated during production.

A4 - Transport to Site

This stage accounts for the transportation of the finished composite panels from the manufacturing plant to the construction site or customer location.

A5 - Installation

Installation-related impacts vary significantly depending on the project and application and are therefore not included. Only the end-of-life treatment of packaging materials is considered in this stage.

C1 - Deconstruction, demolition

End-of-life processes are largely influenced by project-specific factors such as the type of structure, dismantling method (manual or mechanical), and the nature of the final product (extruded profile). Therefore, a generic calculation following the PCR 2019:14 v.2.0.1 is used where 1.1 kWh diesel consumption is assumed per ton of product.

C2 - Transport

After dismantling, the aluminium parts are transported to scrap collection and recycling centres. In the absence of specific data, transportation assumptions are based on the default scenario where 80 km average distance using a Euro 5 lorry with 50% load factor is considered.

C3 - Waste Processing

Recovered aluminium scrap is sorted, cleaned, and pre-treated before re-entering the recycling process. Due to aluminium's high recyclability, most of the material is remelted and reused as secondary aluminium. Recycling-related energy use and emissions are included in the assessment. In line with the latest EU PEF Guidance, a 95% recycling rate is assumed for collected scrap, mainly from building elements, with waste processing impacts considered according to the relevant PCR defaults. As worst-case scenario, other parts of the product is assumed landfilled.

C4 - Disposal

Owing to factors such as mechanical separation losses, material degradation, contamination, and limitations in collection systems, a 5% loss rate is assumed during the end-of-life phase. This unrecoverable fraction is treated as inert waste and directed to landfill disposal. The environmental impacts linked to this final disposal route are included in the assessment at this stage.

D - Reuse, recovery, recycling potential

At the end of the product's life, it is assumed that 95% of the aluminium is collected and recycled. This benefit is quantified by considering the avoided impacts of primary aluminium production, following the EN 15804+A2 standard to prevent any double counting.
